JOINT INFECTIONS LINKED TO USE OF BAIR HUGGER FORCED-AIR WARMING BLANKET DURING SURGERY

Recent studies have linked postsurgical joint infections to the use of a device known as the Bair Hugger, which is a forced-air warming blanket that may be used during surgery to help regulate body temperature.

It is well known that airborne particulate bacteria are a major source of contamination in the operating room. There is now concern that the convection currents created by Bair Hugger may stir up these contaminants and bacteria, bringing them into contact with the joint being operated on. In fact, one study found that there were 2,000 times more contaminant particles in the air over the wound with Bair Hugger forced-air warming than with an alternative air-free warming device.

Even the inventor of Bair Hugger, Dr. Scott D. Augustine, has warned that his invention is a danger to surgical patients receiving implant devices because the warmed air - which is carried through a hose to the Bair Hugger - can spread bacteria associated with hospital-acquired infections.

After a hip or knee replacement surgery, patients typically face a long road to

recovery even without complications. For patients who suffer from dangerous PJIs from bacteria that enter the body during surgery, the impact can be catastrophic, resulting in additional hospitalizations, additional surgery, IV antibiotics, removal of the implant, and amputation. These periprosthetic joint infections can occur months or even years after the initial implant surgery and tragically, can affect areas of the body other than the initial site of the joint replacement.

In recent years, patients who have developed severe Bair Hugger joint infections have filed lawsuits against the manufacturer 3M. The lawsuits allege that 3M was aware of the potential risk of periprosthetic joint infection, yet failed to properly inform the public.

Surgeon Scorecard: Docs Measured by Complications

Consumers now have access to data on how surgeons around the country are scored against their peers in a new online statistical research tool developed by the non-profit news organization ProPublica. Close to 17,000 doctors performing one of eight low-risk, common, elective (non-emergency) procedures such as gallbladder removal and hip replacements are measured in the new calculation. The public can access this research tool at https://projects.propublica.org/surgeons.

The report factors in various risks a surgeon encounters and adjusts the complication rates based on patients' ages, the quality of the hospital where the surgery took place, and other factors.

Although this public exposure is sure to make some medical professionals uncomfortable, it is a small price to pay for better patient care and arming medical consumers with the information that they need when selecting a surgeon.

The stakes are high for patients: about 66,000 cases of complications led to additional hospitalizations between 2009 and 2013, and at least 3,400 people died in the hospital after being admitted for one of the reviewed elective surgeries. However, the good news is that it found an overall low rate of death and readmission across the country — less than 5% for the eight procedures studied.

Having a surgical procedure at an elite institution with an outstanding reputation does not guarantee a good outcome. The ProPublica analysis found substantial variation within hospitals. So why do doctors working with the same staff and high-tech equipment have varying scores? The analysis and research suggest that complications can depend on doctor skill, a strict adherence to best practices with procedures, the volume of surgeries and direct follow-up and personal contact.

This ProPublica research tool is an important step to providing consumers of medical care the data they need to make informed decisions about their medical care.

PLAYGROUND SAFETY TIPS: THE TOP 10

Although playground safety has improved over recent years, it's important to be aware of common risks:

- **1. Fall-Surface Material**: Surfaces below playground equipment should be made of soft material such as wood chips, mulch, sand, rubber mats. The thicker the soft fall-surface the better!
- 2. Size of Fall-Surface Surface Area: The greater and broader the soft surface below playground equipment the safer; a minimum of six feet in all directions is advised.
- **3. Clear Openings:** Wide openings on slides and tunnels help minimize the risk of getting stuck while at play.
- **4. Safe Clothing**: Drawstrings or other loose clothing items can get caught in playground equipment.
- **5. Overcrowding**: Too many children competing for a spot on a piece of equipment increases the risk of injuries.
- **6. Smooth Footing**: Watch for potential trip hazards that could cause your little one to take a tumble.
- **7. Safe Supervision**: Keep a watchful eye out for your child at all times.
- 8. Age-Appropriate Activities: Help to ensure your child's safety by not sending your three year old out to conquer the monkey bars or at least not alone. Take into consideration which playground activities are age- and skill-appropriate and lend a helping hand as needed.
- **9. Friendly edges:** Smooth edges on all equipment are a must, as are soft seats on swings.
- **10. Updated Equipment:** Today's playground equipment should feature safety railings, especially on high platforms.
