# Failed Design: Patients with Stryker Hip Implants Will Require Replacement Surgery

Our firm is representing individuals who had a hip replacement surgery between 2009 and 2012 and were

implanted with a Stryker Rejuvenate or ABG-II prosthetic hip. Stryker recalled these two devices in 2012 and entered into a large settlement with thousands of people who have already had a revision surgery. However, over 20,000 people were implanted with one of these devices between 2009 and 2012 - 100% of which are going to fail - meaning that there are thousands more implant patients who were not included in that settlement and still have not been compensated.

The Stryker Rejuvenate and ABG-II hips were marketed as a new technology, using a two-piece stem (called a "modular stem"). The selling point was that the pieces would come in different shapes and sizes, so the surgeon could better conform the implant to the patient's anatomy. The problem, however, is that metal Stryker used corrodes inside the

body and metal debris is released into the bloodstream and surrounding tissues, killing the tissues, and leading to the formation of psuedotumors.

When people receive a hip replacement, most of them do not know what kind of implant the doctor used. Thousands of people are still out there with one of these defective Stryker hips inside of them, and they may not find out until significant damage is already done. Patients can call their doctor or hospital to find out what kind of hip they received, and if they did receive one of these defective Stryker hips, they can have their blood tested for Cobalt and Chromium to determine if this corrosion is occurring.

# September is National Baby Safety Month

In honor of National Baby Safety Month, we want to help spread awareness about ways to reduce the risk of Sudden Infant Death Syndrome (also known as SIDS). SIDS is "the sudden and unexplained death of an infant who is younger than one year old." (KidsHealth, 2015). Each year, approximately 4,000 infant deaths occur from SIDS, accidental suffocation, or other unknown causes. (Safe to Sleep, 2015)

Here are some tips for providing babies with a safe sleep environment:

- Always lay your baby on its back to sleep. Studies suggest that babies who sleep on their stomach take in less oxygen.
- A firm mattress topped with a fitted sheet is the safest choice. This helps prevent your infant from becoming tangled up in bedding within the crib area.
- Do not leave any soft objects in the crib with your child. Soft objects increase the risk of SIDS. This includes bumper pads, blankets, pillows, and stuffed toys. If a bumper pad is a must, stick to a mesh "breathable" kind.
- Dress your infant in a onesie, sleeper, or sleep sack for warmth instead of using blankets. This prevents them from becoming entangled in bedding.
- Keep your baby's room temperature between 68 and 72 degrees. This is a comfortable temperature for your infant that is warm enough but will not cause overheating.
- Avoid the use of positioners. Products that claim to reduce the risk of SIDS pose such a threat that the U.S. Food and Drug Administration and the Consumer Product Safety Commission both issued warnings advising against their use.
- Monitor and check in on your baby.
- Check to make sure that your crib and other products meet federal safety standards. Learn more at: www.cpsc.gov/en/Safety-Education/Safety-Guides/Kids-and-Babies/Cribs.

# ASK AN ATTORNEY Jeremy A. Tor, Esq.



Here's a question I'm often asked: "I had surgery a while back and I've never recovered. I believe there were many errors made during the procedure and I'm not really sure what to do. I'm considering pursuing a lawsuit but don't want to rush into things. How soon should I contact a lawyer?"

### The answer is: Promptly.

Your lawyer will normally want to review your medical records and consult with a medical expert before making a determination about whether to recommend that you file a medical malpractice lawsuit.

It takes quite a bit of time to gather all of the relevant medical records and additional time is needed for an expert to review them. All the while, the clock for what is known as the "statute of limitations" is ticking. A statute of limitations is the deadline by which you must file a lawsuit, or else you lose the right to file it. In Ohio, the statute of limitations for medical malpractice cases is just one year (though there may be exceptions depending on the facts).

Given the careful review and analysis the lawyer and experts must complete before deciding whether your bad surgical outcome was caused by substandard medical care and warrants a malpractice lawsuit, this is not a lot of time. So it is important to contact a lawyer as soon as possible to preserve your right to file a lawsuit.
